Administration

Commissioners mark sales tax project milestones

On Nov. 29, commissioners held two sales tax project ceremonies.

Commissioners held a ribbon-cutting ceremony for the Aircraft Rescue and Fire Fighting prop at the Public Safety Complex on Airport Road. The prop has a 64-foot wingspan, an 11-foot-high passenger compartment and different types of doors and engines to provide training on equipment firefighters are likely to encounter at an airport. The prop simulates fuel spills, engine fires, brake and wheel fires, and fuselage fires. The \$9.6 million project was funded by state grants and the voter-approved 1% local option sales tax.

Later in the day, commissioners held a groundbreaking ceremony to mark the start of construction on Phase 2 of the Family Services Center on Gibralter Drive in Port Charlotte. The 18,500-square-foot facility will feature a permanent youth component with classrooms, multi-purpose rooms and a playground, a community garden, Human Services staff offices and county partner office space for the Gulf Coast Partnership, Healthy Start, Area Agency on Aging, Head Start and Children's Advocacy Center.





Charlotte County commissioners commemorated two 1% local option sales tax project milestones on Nov. 29. The Aircraft Rescue and Fire Fighting simulator ribbon-cutting was held at the Public Safety Training Center and the Family Service Center Phase 2 groundbreaking was held at the Gilbralter Drive site behind the Family Services Center Phase 1.

lan debris collection progress

Debris collection continues to be a top priority for the county. Our debris contractor, AshBritt, will pass a major recovery milestone today when it will collect its 2.5 millionth cubic yard of debris.


We estimate the final debris tally will far exceed our earlier estimate of 2.5 million cubic yards and may take several more months. We estimate the debris contactor will collection up to 4.1 million cubic yards of debris. The contractor has been added crews and equipment to increase the pace of collection. We will not stop collecting debris until it is all picked up.


Hurricane lan - Damage Dashboard

After a storm, County departments identify, track, estimate costs and provide status updates on damages to our County buildings and infrastructure. One of the more difficult tasks however is getting these multiple lists and tracking mechanisms into one cohesive listing. Following Hurricane lan, a SharePoint site was created in Fiscal Services, where over 930 individual damage assessment reports will be combined, assigned, and reported on throughout the long road of repairs and reimbursements we have ahead us. This data rolls up in a Dashboard that shows the total County estimated damage costs. This list will continue to grow and receive modifications through the various stages in this process, to include amounts reimbursed by FEIMA, actual costs, and insurance payments. In the end, we will have an extensive list of damages and costs which will show us an actual impact to Charlotte County.

Hurricane Ian Response and Recovery

The Economic Development Office has focused on business outreach following Hurricane Ian. We have reached out to businesses to provide recovery resources and conduct the FloridaDisaster.Biz Business Damage Assessment Survey. We partnered with CareerSource Southwest Florida to open a call center to reach out to Charlotte County businesses. As of December 9th:

- 2,492 outreach calls made to Charlotte County businesses.
- 675 Business Assessment Surveys completed.
- \$239,421,375 million in business damages reported.
- 7,599 resource emails sent.

The Zemel Road Landfill project includes relocating the entrance and scale house. The current scale house at the landfill is a trailer nearing the end of its expected usable lifecycle. The project plan will replace the old facilities and proactively relocate the structures allowing for future growth. The new facility will streamline current landfill operations while fulfilling the future operational needs. The project improves flow in and out of the landfill and traffic control within the site. The new site will have three weigh scales, security and monitoring camera at the scales, access control arms for monitoring traffic flow and disposal material accountability. Upon competition, the new facility will be prepared to take the county into the next generation of solid waste disposal.

◆ The draft Guaranteed Maximum Price (GMP) for the North County Public Works Yard was submitted to County Administration for review and approval prior to going before the Board.






Family Servcies Center (FSC) - Phase II Groundbreaking








On Tuesday November 29, 2022, the Charlotte County Board of County Commissioner's joined the staff and partners of the Family Services Center and the projects' design and construction teams to break ground for its Phase II building. Phase II will expand the footprint of the Center by providing a permanent youth component for the Boys and Girls Club with classrooms and multi-purpose rooms; office space for the remaining Human Services divisions and leased space for additional community partners including the Gulf Coast Partnership, Healthy Start, Area Agency on Aging, Head Start and the Children's Advocacy Center. Like other agencies currently leasing space in Phase I, new partners agree to abide by the shared mission and vision of the Center and engage in the County's award- winning Integrated Client Services Model. Phase I & II will be connected by a landscaped walkway and on the west side of the Phase II building, there are plans for a children's playground and a community garden. The \$10.900,000 project is being funded by the voter-approved 202 1% local option sales tax program, it was designed by Fawley Bryant Architecture and will be built by Tandem Construction. The completion date for this project is November 2023.

FSC Partner's First Year



November marked the first year that Human Services and their ten community partners worked together at the Family Services Center. Each organization completed a year end report that reflected the number and location of clients served, programming they provided and the savings their organizations experienced because of sharing space. It was not at all surprising that the partners collectively served clients in every Charlotte County zip code and had a cost savings of \$339, 000 (rent, utilities, etc.) which was used to expand programming and /or provide additional resources. An unexpected benefit was the time saved that was once used for fundraising.

2022 November Department Activities Cases, Claims & New Applications




Monthly Number of Clients Served

End of Hurricane Season

November 30 marked the last day of the 2022 Atlantic Hurricane Season. Emergency Management Director Patrick Fuller said, "Despite the storm totals this season resembling that of an "average" year, we certainly view this season differently in Charlotte County. No one needs reminding of the severity of Ian as we see the impacts each day as we travel around our community and the region." In an email to county staff at the end of hurricane season, Fuller took a minute to thank staff for their work leading up to, during and post-Hurricane Ian, writing, "Emergency Management would like to express our thanks and gratitude. No words can express just how impressive those efforts have been and continue to be!"

Fuller went on to write that counties impacted by significant hurricanes like Ian are "left forever changed and a new normal must be established. Recovery is no easy task, but whether it is the experience of [Hurricane] Charley or the innate resilience of our community, we are well positioned as a county to ensure we rebuild back stronger and more capable of weathering the next storm."

UNDER CONSTRUCTION

- SR 776 Sewer Force Main Project: Upsizing the existing sewer force main to 12-inch and 16-inch lines along SR 776 from Biscayne Dr. to the Charlotte Sports Park. This is an in-kind project for the Florida Department of Environmental Protection (FDEP) Consent Order. This project is expected to be complete by spring 2023.
- Ackerman Septic to Sewer Project: Construction of a wastewater system to service approximately 2,135 properties with sewer service. Zones 1, 2 and the vacuum station are currently underway. The vacuum station is expected to be complete by spring 2023. Zones 1 and 2 sewer connections are expected to begin after vacuum station completion. For project information: AckermanProject.com
- Deep Creek Sewer Force Main Project: Construction of a larger sewer force main to improve transmission capacity for the Deep Creek neighborhood. Construction of the force main is complete. Crews are paving driveways and restoring the project area. This project is expected to be complete by early 2023. **Project Map**
- Cochran Reclaim Project: Construction of reclaim water mains along the right-of-way of Cochran Blvd. from Quesada Ave. to Peachland Blvd.
