#### **Unfinished Business:**

- a. Deep Creek Boulevard Sidewalk Project: Ms. McDonald read the email from a citizen in Deep Creek Section 20 (see attached); Mr. Adair is not in favor of an assessment rate increase for sidewalks. Discussion ensued about the assessment rate scenarios, and it was confirmed that both Section 20 and Section 23 POA boards were in favor of scenario 1, completing the Deep Creek Boulevard sidewalk in one phase with design in FY24 and construction in FY25.
  - Conversation followed regarding pipe lining and scenario 1B to double the pipe lining budget in FY24 & FY25 to \$300,000 per year. Mr. Jacobus inquired about the debt repayment for paying and Ms. McDonald outlined the budget process. Mr. Dyer motioned to revise the budget for the next cycle and increase the annual assessment to \$305 per ERU [scenario 1B] seconded by Mr. Rabinowitz and unanimously approved.
- b. Preliminary FY24 & FY25 Budgets: Ms. McDonald will forward the revised preliminary budgets once they are available.
