Public Input

Joe Johnston discussed American Compliance Technology (ACT) vehicles, derelict vessels, removal process, photographs, environmental impacts, contract, engineer's report, trip hazard, Marina Riviera, invocation, and public integrity.

Mike Thompson commented on American Compliance Technology vehicles and equipment, derelict vessels, removal process, and environmental impacts.

Bobby Kobalski mentioned Federal Emergency Management Agency (FEMA) reimbursement, Port Charlotte Beach Complex, surrounding counties, misinformation, photographs, tennis and bocce ball courts, playground, and Hurricane Ian.

Tommy Scott, Community Services Director gave a brief overview of Construction Manager – demolition (map in RED), Florida Department of Emergency Management – Abandoned Vessel (AV) / Derelict Vessel (DV) removal

Chair Tiseo noted public input and safety, community efforts, communication, Port Charlotte Beach Fence, parking lot, Florida Division of Emergency Management (FDEM), Move fence to allow for access to limited and safe amenities, boat ramp, catastrophic damage, storm surge events, responsibility, deadline, active construction zones, current conditions, and derelict vessel removal. Commissioner Constance spoke to drone footage, November 26, 2024 Regular and Land Use Meeting presentation, current property conditions, bocce court, public safety and access, damage assessment and repairs, community assets, January 14, 2024 Regular Meeting, state mission, alternative sites, timeline, strategy, financial responsibility, West Coast Inland Navigation District (WCIND), and estimated costs. Commissioner Deutsch discussed authorization, cease and desist order, unexecuted contract, crushing prohibition, stipulations, current park conditions, bocce courts, public safety, plumbing and electric issues, timeframe, estimated reopening date, alternate sites, reimbursement, and deadline. Commissioner Doherty commented on timeframe, temporary license agreement, formal correspondence, ACT, deadline, FDEM, alternative sites, requirement, extension, January 14, 2025 Regular Meeting, derelict vessel removal, and communication. Commissioner Truex mentioned derelict vessel removal, fence relocation, public access points, and public safety.

County Attorney Knowlton interjected on temporary license agreement, January 14, 2025 Regular Meeting, state mission, derelict vessel removal, and funding.

Patrick Fuller, Emergency Management Director responded to FDEM, temporary license agreement, ACT, contract review, alternate site options, determination, flexibility, and reimbursement extension.

Ray Carter, Risk Manager noted damage assessments, demolition project, Port Charlotte Beach Fence, derelict vessel removal, public safety, property access, park amenities, standards, parking, and FDEM.
