1. Call to Order and Pledge of Allegiance— **Chair Darden** called the meeting to order at 9:30 am.
2. Roll Call - Upon the roll being called it was determined a quorum was present.
Sign-In Sheets attached.
3. Chairman's Comments
 - a. Reminders to All Members, and Staff, Visitors: - Please sign in on the sheet provided. State your name and organization when addressing the committee to assist with minutes. Silence cell phones and keep conversations to a whisper, as the recording system captures all sounds.
4. Changes to the Agenda –
The minutes from the September 11, 2025, meeting have not yet been completed.
5. Citizen Comments on Agenda Items –
Chuck Witzke with the Beuna Vista MSBU spoke on a meeting yesterday and discusses dredging, beach sand, community services, money and a grant for \$150K.
6. Regular Business
 - a. The minutes from the September 11, 2025, regular meeting have not been completed.
 - b. Charlotte County Sheriff's Office and City of Punta Gorda Police Dept. – Marine Updates

Charlotte County Sheriff's Office

Sgt. McRae presented the derelict vessels report. He announced that the boat lift installation is scheduled for October 22, 2025, and provided an update on the vessel located at Laishley. He noted that the Marine Advisory Committee will be funding the motors and reported that quotes are currently being obtained, and Waterfest.

Ms. Ginsberg asked Sgt. McRae about the boat in the mangroves. **Deputy Nelson**, from the Marine Division explained the owner passed away and the owner's wife has been working with their office and FWC. He noted that the boat is still afloat.

Mr. MacIntosh spoke about the situation in Chad Cove involving the individual who was recently arrested, and a discussion followed.

Ms. Gassett-Shoemaker commented on the process previously shared and asked about the vessel in South Gulf Cove, specifically whether a placard had been placed on it. **Sgt. McRae** stated that the vessel is an FWC case, and he was not aware whether a placard had been posted. He explained the procedure used for derelict vessels, and discussion ensued.

Mr. Hyde asked about the Manta sailboat, which is also an FWC case, and inquired whether the Punta Gorda Police Department has any involvement with that vessel.

City of Punta Gorda Police Department

Cpl. A. Russell spoke with **Mr. Hyde** regarding the Manta sailboat. They located the owner in Tennessee and explained the actions taken, including placing a sticker on the boat with contact information. He also reported that a 25-foot section of dock is struck in the Peace River; they are coordinating with FWC and have placed a danger buoy near it.

Mr. Hickey stated that someone had been on the boat with the engine running and had attempted to lift the marker but was unsuccessful. He noted that the dock section is now completely submerged, and a discussion followed with **Cpl. Russell**.

Mr. Russell asked whether the boat should be traced like firearms; discussion followed with Officer Russell, Mr. Hyde, Mr. Vigne, and Mr. McKinnon.

c. Derelict Vessel Report – Liz Eastes

d. Water Quality Assessment Program – Richard Whitman/Brandon Moody

Mr. Schutz, CEO of Heal Our Harbor, presented the study results, summarized the project, and introduced Dr. Whitman, Mr. McCague, noted Ms. Karen McCague's absence, and introduced Mr. Moody and Ms. Betsy.

Mr. McCague reported on the development program, 18 months of water sampling, related equipment, and provided a slide presentation and explained everything throughout the slide show.

Mr. Russell asked whether sediment testing had been conducted; Mr. McCague stated Dr. Whitman would address this.

Dr. Whitman reported on testing methods, participating companies, and fecal-matter data from 2018–2024, including Sunrise Waterway impacts, Peace River discharge, and sampling before, during, and after Hurricanes Debby and Helene, with findings on oxygen levels, watercolor, salinity, and DNA source identification.

Mr. Moody discussed state testing results, fecal-matter sources, bacterial findings in two watersheds, and sampling across Charlotte County.

Mr. Hicky asked about implications for the septic-to-sewer project and homeowner costs; discussion followed with Mr. Moody.

Mr. Russell requested clarification on the three sample-color categories (pink, green, yellow) and discussed them with Mr. Moody.

Mr. Hyde asked about non-septic sources of bacterial contamination; discussion followed with Dr. Whitman, Chair Darden, Mr. Moody, and Mr. Russell.

e. FY25/26 Fiscal Reports/Grants – Debbie Thibideau



Mrs. Thibideau presented her report; discussion followed.

Mr. McIntosh reported on the Learn to Sail funding request made with Ms. Thibideau and noted it is proceeding.

Mr. Hyde conferred with Ms. Thibideau regarding pump-out boat funding and reimbursement.

Chair Darden reviewed FY24 open items with Ms. Thibideau; discussion followed.

f. MSBU Update – Matt Logan



Mr. Logan introduced Mr. Benjamin, presented his report, and noted he can revise its layout at the members' request.

Mr. Russell requested information on hot-spot locations, waterway maps, and contract and planning details; discussion followed with Chair Darden and Mr. Logan.

Mr. Hickey asked when barges will be in Alligator Creek; Mr. Logan stated he will address this next month.

g. Community Services Update – Tina Powell



Ms. Powell presented her report; discussion followed with Chair Darden regarding the Placida Boat Ramp and the permit.

Chair Darden outlined the dredging process.

10. Member Discussion –


